

Narrative Explanation

Wards 1 through 5 are identical to the Current Ward Maps with the exception of splitting 2 precincts – La Porte 27 and La Porte 44 (see attached detailed maps). The portion of La Porte 27 bounded by Lawrence Street, Philadelphia Street, Talley Street and Niles Street has been allocated to Ward 4 while the remainder of the precinct is allocated to Ward 1. The portion of La Porte 44 bounded by H Street, F Street, 1st Street and 6th Street is allocated to Ward 2 while the remainder of the precinct is allocated to Ward 5.

If the Redistricting Coordinator's Plan is adopted, the County Clerk will be contacted to request a reprecincting of the City to reflect the foregoing changes prior to the 2027 City election.

Proposed Ward Descriptions

- (1) District 1 (Ward #1) includes the following precincts: La Porte 25; La Porte 26; La Porte 27 with the exception of that portion located south of Talley Street, east of Lawrence Street, north of Niles Street and west of Philadelphia Street; and La Porte 28.
- (2) District 2 (Ward #2) includes the following precincts: La Porte 29; La Porte 30; La Porte 31 and that portion of La Porte 44 located West of F Street.

- (3) **District 3 (Ward #3)** includes the following precincts: La Porte 32; La Porte 33; La Porte 34; La Porte 35 and La Porte 36.
- (4) **District 4 (Ward #4)** includes the following precincts: that portion of La Porte 27 located south of Talley Street, east of Lawrence Street, North of Niles Street and west of Philadelphia Street; La Porte 37; La Porte 38, La Porte 39 and La Porte 40.
- (5) **District 5 (Ward #5)** includes the following precincts: La Porte 41; La Porte 42; La Porte 43 and that portion of La Porte 44 located east of F Street.
