

City of La Porte Historic Preservation Commission Meeting Minutes

A meeting of the City of La Porte Historic Preservation Commission ("Commission") was held at City Hall Council Chambers, 801 Michigan Avenue, La Porte, IN, 46350 on Tuesday, July 15, 2025 at 5:30 P.M. ("Local Time"), pursuant to notice duly given in accordance with the rules of the Commission and the Indiana Open Door Law.

This meeting was called to order at 5:30 PM by Sallie LaRocco, Chair.

- A. HPC Educational Workshop Planning Deb mentioned that they are working on a workshop in South Bend this September on masonry repairs.
- B. Section 106 Review Correspondence for Housing Opportunities, Inc. Project at 205 Rumely Street (Coca-Cola Bottling Company Building) Sallie explained that Housing Opportunities submitted a request for review on a proposed project to demolish the building at 205 Rumely Street and replace with new construction for apartment units and supportive services provided by Housing Opportunities. Fonda mentioned that the board should make a recommendation to preserve the historical elements in the building within the new development.

Peter mentioned that if they plan to build a new building, it should look more residential in nature similar to the surrounding homes in the neighborhood. The board continued discussion on the appropriateness of the request and asked City staff to email the information out to the full board so that everyone has a chance to review the proposal before submitting a response letter.

- A. At-risk properties discussion Sallie explained that she would like the board to come up with a few properties that should be on the top five at-risk properties and bring them to the next meeting.
